**GENERAL TERMS:** This Credit Application (“Application”) is between Abel Industries, Inc. (“Abel”) extending credit and the Applicant named on page one hereof (“Applicant”). Applicant acknowledges that Applicant is furnishing the information requested herein, including Applicant’s financial statement, for the purpose of procuring commercial business credit from time to time

with Abel. Applicant represents and warrants that said information is true and correct and an accurate and complete statement of Applicant's financial condition. Applicant authorizes Abel to obtain credit and financial information concerning Applicant at any time and from any source for the purpose of establishing and maintaining credit for the Applicant. In addition, Applicant authorizes Abel to contact the credit references listed herein and hereby grants permission to those references to release requested information about Applicant's credit history. Applicant further agrees that this Application can be mailed to said references and/or other credit sources. The Applicant also releases Abel, its officers, directors, shareholders, and affiliates from any and all liabilities related to contacting the above references or other credit sources. Applicant agrees to assume all state sales taxes. Applicant agrees that this application is for non-consumer, business credit use only.

Should this Application be accepted and credit extended to Applicant, Applicant agrees that this Application was entered into at the offices of Abel, located in Prince William County Virginia. Applicant further agrees to inform Abel within 10 days, at the address set forth on page one, of any changes to Applicant's name, business status or ownership. Applicant also agrees to advise Abel of any defective product provided by Abel Industries, Inc. within 10 days of receipt. Applicant further agrees to examine immediately upon receipt, each of Abel's invoices, and to advise Abel of any disputed transactions or invoices within 10 days of receipt, together with a written statement specifying the reasons for such dispute. Failure to notify Abel of any dispute with respect to defective goods or billing shall constitute a waiver of such dispute. Applicant will not withhold payment when disputes arise.

Applicant further agrees that all warranties on goods sold, if any, are limited to those given by the manufacturer and in no event will Abel be responsible for installation or labor charges. All goods are sold F.O.B. shipping point with the risk of loss or damage shifting to the Applicant upon Abel's delivery to the Applicant or common carrier. Abel reserves the right to cease extension of credit without notice.

**ENTIRE AGREEMENT:** This Application, along with the terms and conditions set forth on Abel's quotations, invoices and delivery tickets (incorporated herein by this reference), constitute the entire agreement between the parties and supersede any terms and conditions set forth on any purchase order submitted to Abel by Applicant. Applicant hereby agrees to be bound by such terms and conditions. Applicant hereby agrees that the terms and conditions of any purchase order, other than the identity of and quantity of material being purchased, are null and void and of no legal effect.

**TERMS OF PAYMENT:** In consideration of Abel extending credit to Applicant, Applicant agrees to pay for all services and materials provided to or at Applicant's request according to terms and conditions stated herein and on invoices as issued by Abel. All accounts are due and payable at the remittance address shown on the Abel invoice. Applicant agrees that Abel is authorized to apply all unspecified payments at Abel's discretion. Payment is due within thirty (30) days after the invoice is issued and if not timely made then Applicant shall be in "Default". Applicant agrees that it will be charged interest of one and one-half percent (1.5%) per month (18% per annum) for any unpaid balance that is thirty days past the date the invoice was issued. A portion of the month shall be treated as a full month for the purposes of calculating the interest charge when Applicant is in Default. Applicant also agrees to promptly pay said interest charge. Waiver of any charge for any one month shall not be deemed a waiver of future charges. In the event of Applicant's Default, Abel may, at its option, without demand, declare all obligations immediately due and payable.

In addition to paying all sums due hereunder, Applicant agrees to reimburse Abel for all costs of collection including, without limitation, reasonable attorney's fees of not less than thirty-three and one-third percent (33.33%) of the outstanding balance, collection agency fees, expert witness fees, expenses and costs including those associated with the filing of any lien or other action filed due to Applicant's nonpayment.

Applicant further agrees that all funds owed to or received by Applicant from any source, resulting from the services and/or materials supplied by Abel, shall be held in trust for the benefit of Abel. Applicant agrees to promptly pay to Abel all such funds. Upon request, Applicant shall irrevocably assign to Abel its accounts receivable from anyone to the extent that such receivable results from services and/or materials supplied by Abel.

**CREDIT LIMIT:** Upon approval of this Application, Applicant may receive a credit limit which may or may not be in excess of the credit limit requested by Applicant. Should the credit limit be exceeded, Applicant acknowledges sole liability for the full amount due and owing, including all amounts in excess of the credit limit, and further acknowledges that Abel shall have no liability arising out of a credit limit being exceeded.

**ASSIGNMENT:** Applicant agrees that it will not factor, sell or assign the debt related to the credit granted by Abel under the terms of this Application.

**DISPUTE RESOLUTION:** Any dispute arising out of this Application shall be resolved by litigation or binding arbitration at Abel's option and at a venue selected by Abel. In the event that Abel elects binding arbitration, a single arbitrator shall preside over the arbitration and, if the parties cannot mutually agree upon a single arbitrator, then one shall be selected by the arbitration service selected by Abel. Applicant also agrees to be bound by the arbitrator's decision. Applicant further agrees to waive any claims against Abel for any consequential damages, including but not limited to, lost profits, and for punitive damages in any arbitration or litigation matter. Applicant also agrees that should Abel prevail Applicant shall reimburse Abel for all of its costs incurred in resolution of said dispute to include without limitation reasonable attorney fees, expert witness fees, expenses and costs.

**GOVERNING LAW:** This Application shall be governed and interpreted in accordance with the laws of Virginia. The undersigned, to include without limitation the Applicant and any guarantor, agree that all claims and disputes arising out of or in connection with this Application if not subject to arbitration shall be adjudicated in the courts of Prince William County and consent to the jurisdiction of those courts for the purposes of enforcing any obligations under this Application. The undersigned further WAIVE TRIAL BY JURY IN ANY ACTION OR PROCEEDING BY OR AGAINST ABEL UNDER THIS APPLICATION.

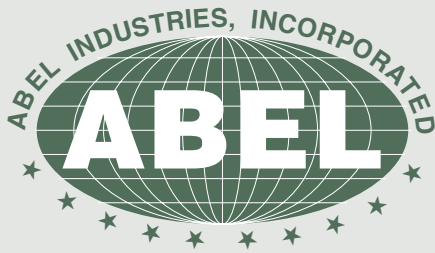
