## Terms and Conditions for a Net 30 Day Account.

(updated June 15, 2001)

- 8 Any outstanding balances are subject to an interest fee of 1.5% per month (18% per annum).
- 8 We accept **Company Checks, Personal Checks, Cash, Visa, Master Card, American Express, and Discover**. (note: if account placed on C.O.D. and you wish to use a credit card, you must call in your card information prior to delivery. Our drivers can not accept credit cards)
- 8 Any returned checks will be subject to a **\$40.00** fee.
- 8 We reserve the right to review credit payment history and either raise, lower, hold, or place account on C.O.D. (if credit terms are not being met).

- 8 All prices are subject to change without notice.
- 8 Written quotations are good for 30 days unless otherwise noted.
- 8 Changes in quoted quantities at time of delivery may result in price changes.

- 8 Any orders less than \$75.00 will be subject to a **\$10.00** delivery fee.
- 8 Orders outside of our normal delivery area will be serviced by common carrier or parcel service and may be subjected to an additional delivery fee.
- 8 All merchandise must be signed for at time of delivery. Signature on **POD** (proof of delivery) will designate that all merchandise was received in proper condition and correct quantities. Any items **NOT** received or damaged **MUST** be noted on the **POD** in order for you to receive credit for any missing or damaged goods.

- 8 To **insure proper credit** for returned in-stock items, you must have approval authorization **within 7 days** of receipt of merchandise from our main office and you will have 30 days in which to return these items. After the 30 days period your authorization becomes null and void. Please call our customer service number to get authorization for pick up of your merchandise. No returns will be accepted for partially used items or partial cases unless defective. No returns will be picked up or credited after 30 days from receipt of merchandise. Some items from our catalog may be subject to a 25% restocking fee if authorization from Abel Industries has not been done within the 7 day period.
- 8 Any special orders (orders other than out normal stock) **MUST have written authorization** to be returned from Abel Industries **within 7 days** of receipt of merchandise. If Abel Industries can not get authorization from our manufacturer to return these items to them, **we cannot accept your returned merchandise**. If these items can be returned, you may be subject to a **restocking fee of 25%** of the sale price of the merchandise plus any additional freight charges associated with returning this merchandise to our manufacturer. Any original freight charges previously invoiced to you associated with the special order will not be refunded.
- 8 All equipment sales are final and can not be returned if used unless there is a manufacturer's defect.

- 8 Claims for goods damaged by common carrier or parcel service are to be submitted to the appropriate carrier.
- 8 If an item purchased is found to be incorrect or defective, Abel Industries will either replace the item with an equal quality or refund the original purchase price at Abel industries' sole discretion. In cases where the manufacturer's instructions or generally accepted installation practices are not followed, no credit will be allowed for the return of the product. Any alteration of any product will void its warranty.
